This membership entitles one member of the household to unlimited golf. Member, Spouse/Domestic Mate and dependent children may access all other privileges of membership per CCC, Inc. By Laws and Rules. Membership includes one vote and member may hold office. Minimum 1 year commitment.

_Social Membership, Fee Per Month \$_____

This membership entitles member, spouse/domestic mate and dependent children limited non-voting membership with access to all privileges of membership per CCC, Inc. By Laws and Rules, except Golf. Membership does not include any voting privileges or right to hold office.

_Other, Fee Per Month \$_____

Board of Directors may implement a new membership classification. Fees and Rules may vary. Refer to special rules and guidelines for membership privileges per the attached membership offer.

Initiation and Account Set Up of Membership Account requires a non-refundable deposit of \$______which is due at time of application. If application is not approved, a full refund will be issued back to the applicant.

Membership in Chaparral Golf and Country Club is a privilege provided by the members of CCC, Inc. through the direction and authority of the Board of Directors.
